Appendix Example Research Projects

In-home technologies to improve social connection for health among seniors (2007)

Funded and managed by Intel Corp, the TRIL interdisciplinary research centre brought engineers, medical practitioners and social ethnographers into a programme of in-home technology trials to develop prototype technologies to facilitate independent living.

My own role was to lead the social connection strand in developing studies to meet this end. This included the recruitment and assessment of a cohort of 600 Irish seniors who participated in in-home technology trials; work with engineers to innovate, develop and build new technologies engaging olderusers as co-designers; design and conduct usability studies of early prototypes; establish and design social connection component of outpatient clinical assessment centre.

Decision making around prevention, diagnosis and treatment of chest pain (2004-2006)

In conjunction with an RCT evaluating the use of guidelines versus appropriateness ratings for referral and investigation in patients with suspected or confirmed angina, this ethnographic study of clinical decision making in outpatient clinics explored how practitioners assemble diagnosis from history taking and diagnostic testing in routine practice. Funded by the NHS Service Delivery Organisation (SDO) this

work has been employed to help explain 'missed' or delayed diagnosis of Coronary Artery Disease (CAD) in primary care and rapid access chest pain clinics.

PHD THESIS: THE LOCATION OF RISK: DANGER, PLACE AND ANTHROPOLOGY, (1998-2003)

Funded by the Medical Research Council's (MRC) first collaborative doctoral award with social anthropology, the research established an innovative cross-disciplinary collaboration between the Department of Social Anthropology and Institute of Public Health(IPH), University of Cambridge. The anthropological research was nested within the development of a clinical programme to prevent type 2 diabetes in high risk groups where anthropological analysis identified factors that hindered and facilitated uptake of and compliance to the program. The MRC went on to fund this early pilot study as an RCT examining the efficacy of a home-based programme to increase physical activity among populations at increased risk of type 2 diabetes.

The PhD research explored medical/epidemiological conceptualisations and classifications of risk in contrast with lay/public perceptions of risk. Fieldwork was conducted at the IPH, primary and secondary care clinics and home-based interviews. The data exposed the symbiotic relationship between contrariety and coherence of risk classifications as understood in both public health and epidemiology as well as lay / experiential perceptions of risk of future illness and /or disease.

My PhD supervision was overseen by Prof Marilyn Stathern and collaboratively supervised by Dr Stephen Hug-Jones and Professor Ann-Louise Kinmonth.
