Multi-stakeholder diplomacy is evolving rapidly, not only as a key cross-cutting strategic component in international relations, but also by the magnitude of actors involved in global health. A range of stakeholders from governments, civil society organisations and the private sector play influential roles at varying stages and levels of global health diplomacy. Pressing health issues can only be addressed and solved collectively with all actors being involved. This complexity requires on the one hand, a thorough analysis and assessment of the interests and needs of each stakeholder, and on the other hand, political leadership and negotiation skills to navigate effectively diverse environments.

COURSE CONTENT

This course will seek to explain how these stakeholders interact and manage their roles and responsibilities at the various stages of negotiation processes, and how they balance requirements, expectations and accountability. This year's course will in particular:

- → Explore the complexities of multi-stakeholder diplomacy and governance for global health in the 21st century;
- → Apply a differentiated analysis of actors and their interests on specific thematic issues, such as NCDs, AMR and UHC:
- → Reflect upon the extent to which health can or should be regulated, including a discussion on marketing and regulations in the context of NCDs and digital health:
- → Learn from organisations on how they approach multistakeholder negotiations in global health, in particular on how they manage conflicts of interests;
- → Review the challenges of inter-sectoral integration and multi-stakeholder governance in global health.

The course is highly participatory, drawing on the national and international professional experiences of participants through a multi-disciplinary learning process. It includes lectures and panel discussions with internationally-renowned experts and negotiators, case studies, working groups, and skill-building negotiation exercises.

- → Health and international relations professionals in departments of international health, ministries of foreign affairs and development cooperation
- → Health attachés and diplomats with a portfolio impacting on health
- → Representatives from international, regional and nongovernmental organisations
- → Professionals in philanthropic organisations, the private sector and academia

COURSE OBJECTIVES

- → Gain insight into multi-stakeholder diplomacy and governance for health
- → Improve efficiency in navigating complex multi-issue and multi-stakeholder environments by enhancing your negotiation skills.
- → Improve strategies and tactics of dealing with 'delicate situations' and manage conflicts of interests
- → Promote a network of global health diplomats and foster peer learning
