Co-Chair and Research Director, Forum on Global Governance for Health, Harvard Global Health Institute and Harvard School of Public Health



Suerie Moon, MPA, PhD is Research Director and Co-Chair, Forum on Global Governance for Health, Harvard Global Health Institute and Harvard School of Public Health. She is also the Co-Director of the Project on Innovation and Access to Technologies for Sustainable Development, Sustainability Science Program, Harvard Kennedy School of Government. Her work focuses on global governance, the evolution of international regimes, the political economy of global health (particularly innovation, access to medicines, intellectual property and equity), and innovative policies for addressing global problems. Prior to coming to Harvard, she worked for the Médecins Sans Frontières/Doctors Without Borders (MSF) international Campaign for Access to Essential Medicines, where she focused on intellectual property rights, equity prices for medicines, and research and development into neglected diseases. She has also

consulted on access to medicines policies for MSF, Oxfam, the Medicines Patent Pool, UNAIDS, UNITAID and the World Health Organization. Dr. Moon is a member of the Board of Directors of MSF-USA, the Drugs for Neglected Diseases Initiative-North America, the expert Proposal Review Committee of UNITAID, and the Global Advisory Committee of the WHO project on local production for access to medical products. She received a BA in History from Yale University, an MPA from the Woodrow Wilson School of Public and International Affairs at Princeton University, and a PhD in Public Policy from the Harvard Kennedy School of Government.

Professor, Institute of Global Health Innovation, Imperial College, London



Stephen Matlin, PhD, DSc, is a former Executive Director of the Global Forum for Health Research (GFHR), promoting health research for the needs of low- and middle-income countries. He worked in academia for over 20 years, researching, teaching and consulting in medicinal, biological and analytical chemistry, collaborating with the Special Programmes in human reproduction and tropical diseases at WHO and the International Organization for Chemical Sciences in Development (IOCD). In 1995 he left academia to work full time in international development, holding senior positions in the Commonwealth Secretariat and UK Department for International Development, before joining GFHR. Professor Matlin has served as Kelvin Lecturer of the British Association for the Advancement of Science; President of the British Association for International and Comparative Education; Vice-President of the Royal Institution of Great Britain; Vice-President and Chair of the Commonwealth Association of Science, Technology and

Mathematics Educators; and Senior Research Fellow at Oxford University. He has served on the governing bodies of the Alliance for Health Policy and Systems Research, the Child Health and Nutrition Research Initiative, the Initiative for Cardiovascular Health in Developing Countries; and currently serves on the board of IOCD and Steering Committee of the Netherlands Global Programme in Health Policy and Health Systems Research; and is an Adjunct Professor in the Institute of Global Health Innovation, Imperial College London. He was a co-founder and co-chair of Global Health Europe. He has published more than 250 papers, articles, reviews and book chapters. He has experience working with governmental, inter-governmental and non-governmental agencies in areas including policy and strategy development, capacity strengthening, advocacy, facilitation and consensus building, priority setting and resource tracking.

OPENING REMARKS

MARIE-PAULE KIENY

Assistant Director-General, Health Systems and Innovation, WHO



Dr Marie-Paule Kieny was appointed WHO Assistant Director-General for Health Systems and Innovation in November 2012. Dr Kieny was WHO Assistant Director-General for Innovation, Information, Evidence and Research from October 2010-November 2012. Prior to this, Dr Kieny directed the WHO Initiative for Vaccine Research since its inception in 2001. Vaccines against poverty-related diseases and those that disproportionately affect poor and marginalised populations are continuing priorities since her first role in WHO with the Special Programme for Research and Training in Tropical Diseases in 2001. Before coming to WHO, Dr Kieny held top research positions in the public and private sectors of her home country, France. The positions included Assistant Scientific Director of Transgene S.A. from 1981 to 1988, and Director of Research and Head of the Hepatitis C Virus Molecular Virology Group at the Institute of Virology, Institut national de la santé et de la recherche médicale (INSERM) from 1999 to 2000. She received her PhD in Microbiology from the University of Montpellier in 1980, where she was also awarded a University Diploma in Economics, and her Diplôme d'Habilitation à Diriger des Recherches from the University of Strasbourg in 1995. Dr Kieny has published over 250 articles and reviews, mainly in the areas of infectious diseases, immunology and vaccinology. Dr Kieny was awarded the coveted Chevalier de l'Ordre National du Mérite, au titre du Ministère de la Recherche (2000); the Prix Génération 2000-Impact Médecin (1994); and the Prix de l'Innovation Rhône-Poulenc (1991).

She has published widely on issues of global governance and the financing of international cooperation and is the lead editor of *Providing Global Public Goods; Managing Globalization* and *The New Public Finance; Responding to Global Challenges* (OUP: New York, 2003 and 2006, respectively) and co-author of the *Governance Report 2013* (OUP: Oxford, 2013). Visiting Professor, Department of Global Health and Population, Harvard School of Public Health; Professor, Department of Health Management and Health Economics, Institute for Health and Society, University of Oslo



John-Arne Røttingen MD PhD MSc MPA is Professor of Health Policy at the Department of Health Management and Health Economics, Institute of Health and Society, Faculty of Medicine, University of Oslo, and currently Visiting Professor at the Department of Global Health and Population, Harvard School of Public Health and Institute Visiting Scholar at the Harvard Global Health Institute. He is a research associate of the European Observatory on Health Systems and Policies, Chair of the Board of the Alliance for Health Policy and Systems Research, member of the Scientific Oversight Group of the Institute for Health Metrics and Evaluation, University of Washington, Seattle, and was the Chair of the former Consultative Expert Working Group on Research and Development: Financing and Coordination (CEWG) at WHO. He has been Director General of the Norwegian Knowledge Centre for the Health Services, Norway Oxford Scholar at Wadham College and Fulbright Fellow at Harvard Kennedy School.

ELIZABETH MCALLISTER

Senior Advisor, Strategy, Results and International Evaluation



Elizabeth McAllister has served in leadership positions in the international development community for over 25 years. From 1997 to 2005, she held a number of senior assignments at the World Bank in Washington, D.C., including Director of the Operations Evaluation Department (OED), Director of External Affairs and United Nations Relations and Special Advisor to the Vice Presidency for East Asia and Pacific. Prior to joining the World Bank, Ms. McAllister held executive positions in the Canadian International Development Agency (CIDA) including Director General of Performance Review, Director General for Latin American and the Caribbean Region, Director of the China Country Program and Director of Women in Development. She twice chaired the DAC Working Group on Women In Development. From 1985 to 1988, she was Counselor for Development in Jakarta, Indonesia. Ms McAllister enjoys an active practice in international development with clients including the World Bank, UN Food and Agriculture Organization (FAO), International Fund for Agricultural Development (IFAD), the Global Environment Fund (GEF), the United Kingdom's Department for International Development (DFID), International Federation of the Red Cross and Red Crescent Societies, (IFRC) Canadian International Development Agency (CIDA), Caribbean Development Bank (CDB), MOPAN and the Consultative Group on International Agricultural Research. She is a member of the Advisory Council to the Gregg Center for the Study of War and Society at the University of New Brunswick, and the McLeod Group. Ms. McAllister is a recipient of numerous awards for community service and leadership, including a 1994 Governor General's Commemorative Medal for service to Canada. A graduate of Harvard University's Kennedy School of Government (MPA) and the University of New Brunswick, she lives in Ottawa, Canada.

LIANE SCHALATEK

Associate Director, Heinrich Böll Stiftung North America



Liane Schalatek is the Associate Director of the Washington Office of the Heinrich Böll Stiftung, a position she has held since 1999. Since 2008, she has been leading from Washington, DC the work on climate finance for the Heinrich Böll Stiftung (a German non-profit political foundation affiliated with the German Green Party) and its 28 offices worldwide. She is currently following closely the efforts to operationalize the new Green Climate Fund (GCF) and was involved in its design process from the beginning in 2011. She is also a leading expert on gender and climate finance. She co-founded and co-leads one of the primary civil society climate finance transparency efforts, website www.climatefundsupdates.org, a joint project with ODI. She has been engaged as a civil society observer in UNFCCC climate negotiations since COP 14. Prior to 2008, she lead the Foundation's work in Washington on macroeconomic policy issues (international trade and finance) with a special focus on mainstreaming gender equality concerns into the foundation's work and the work of its partner organizations worldwide. A journalist by training, she has published widely on these issues and holds an M.A. in International Affairs from George Washington University in Washington, DC and an M.A. in Political Science and Political Economy from the University of Erlangen, Germany.

AURELIA FIGUEROA

Policy Analyst and Researcher at the German Development Institute / Deutsches Institut für Entwicklungspolitik (DIE)



Aurelia Figueroa has provided energy sector policy and investment analysis in international organisations, the public sector and private sector. Currently, she is a Policy Analyst and Researcher at the German Development Institute / Deutsches Institut für Entwicklungspolitik (DIE), a leading development policy think tank globally. Her research focuses on energy sector finance, risk management for low-carbon development, and the governance of international energy industry co-operation. She is a member of the Emerging Leaders in Energy and Environmental Policy Network. Most recently, she contributed as author and editor to the Organisation for Economic Co-operation and Development (OECD) publication *Meeting Global Challenges through Better Governance: International Co-operation in Science, Technology and Innovation*. Prior to joining the DIE, Aurelia completed a Robert Bosch Foundation Fellowship with appointments at the

Energy Policy Division of the German Federal Ministry for Economics and Technology (BMWi) and in Government Affairs at Siemens AG. Aurelia holds a Master of International Affairs degree with an emphasis in international economic development from Texas A&M University.

MICHEL KAZATCHKINE

UN Secretary-General Special Envoy on HIV/AIDS in Eastern Europe and Central Asia; former Executive Director, The Global Fund to Fight AIDS, Tuberculosis and Malaria



Professor Michel D. Kazatchkine, MD has spent the last 25 years fighting AIDS as a leading physician, researcher, administrator, advocate, policy maker, and diplomat. He attended medical school in Paris and has completed postdoctoral fellowships at St Mary's hospital in London and Harvard Medical School. He is Professor of Immunology at Université René Descartes in Paris and has authored or co-authored over 500 articles focusing on autoimmunity, immuno-intervention and HIV/AIDS. Dr. Kazatchkine has played key roles in various organisations, serving as Director of the national Agency for Research on AIDS (ANRS) in France (1998-2005), Chair of the WHO's Strategic and Technical Committee on HIV/AIDS (2004-2007), member of the WHO's Scientific and Technical Advisory Group on tuberculosis (2004-2007), and first Chair of the Global Fund's Technical Review Panel. Dr Kazatchkine has been a member of the Global Commission on drug policies since its creation in 2010. He has served on the Governing Council of the IAS from 2004 to 2012. From 2005 to 2007, he served as French Ambassador on HIV/AIDS, Board member and Vice-Chair of the Board of the Global Fund to fight AIDS, tuberculosis and malaria (2005-2007). In 2007 Dr. Kazatchkine was elected Executive Director of the Global Fund, a position in which he served until March 2012. In July 2012, Dr Kazatchkine was appointed as the UN Secretary-General's special Envoy on HIV/AIDS in Eastern Europe and central Asia.

Senior Patent Examiner and Head of Outreach, Research & Collaborations, Kenya Industrial Property Institute

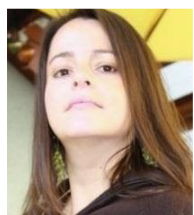

Mr Misati was actively involvement in the negotiations and drafting of break-through decisions of WTO on TRIPS and public health under the Doha Development Agenda, and WHO's Global Strategy and Plan of Action on Public Health, Innovation and Intellectual Property. He has been a member of the Technical Committee for EAC Cooperation on TRIPS

and Access to Medicines since March 2005. He was the Regional Expert in the development of the EAC Regional policy and protocol on WTO-TRIPS and public health. He is the Ministry of Industrialization's IP advisor to the Ministries of health. He chairs WTO-TRIPS National Sub-Committee on Kenya's Implementation of the TRIPS Agreement. He regularly resources in local, regional and international forums in IP and public health. He has undertaken consultancies for UNCTAD, EAC-GTZ, EABC-GIZ, FEAPM, among others, on IP and public health. He has published several research papers on IP and public health including TRIPS flexibilities. He has a Master of Intellectual Property, Bachelor of Science amongst other academic/professional qualifications from institutions in Kenya and abroad. He is currently pursuing an Executive Master of Science in Applied Leadership and Management.

CAROLINA GÓMEZ

Carolina Gómez is a Colombian lawyer specialised in intellectual property.
