Prof. Liliana Andonova, Co-Director of the Centre The scope of accountability for International Environment Studies (CIES), has sured, using innovative layering

New SNF project awarded to Prof. Liliana Andonova

Prof. Liliana Andonova, Co-Director of the Centre for International Environment Studies (CIES), has been successfully awarded a research grant of CHF 862'453.- by the Swiss National Science Foundation. The 4-years project *Accountability of International Organisations* will aim to investigate under what conditions and to who are International Organisations (IOs) accountable to for their decisions, operations and practices.

This project will seek to develop a broadly generalisable theory that places a spotlight, for the first time, on explaining the variable accountability of IOs, and how institutional design and political action affect the scope of international accountability.

It will inform a comparative empirical analysis on the accountability of five IOs (ICRC, UNICEF, the World Bank, the IMF, and the WHO), selected according to the expected variation in their institutional structure and other explanatory variables. The scope of accountability of IOs will be measured, using innovative layering of methodologies from multiple social science disciplines, including analysis of historical archives and legal instruments, and inter-temporal and comparative analysis on who are the formal and informal accountability holders, and through what accountability mechanisms they access information, demand justification, or impose consequences.

The project aims to make substantial contributions to International Relations theories, the study and teaching of international institutions, and, importantly, to public policies and IO reforms.

CIES is pleased to host Professor Peter Rosset for its next Geneva Dialogue lecture on *Climate Change, Social Movements and Peasant Agroecology.*Peasant farmers are prime victims of climate change. Increasing variability in rainfall and temperatures disrupts planting and what the peasant movement calls 'false solutions', such as agrofuels and REDD, which lead to further land grabbing and dispossession, doubly victimising the peasantry. The transnational peasant movement La Via Campesina (LVC), asserts that peasants also hold the promise of a true solution that could

substantially scale back greenhouse gas emissions: relocalising the global system by building food sovereignty, based on anti-capitalist struggle, the roll-back of free trade agreements, true agrarian reform and peasant agroecology. Beyond its well known engagement in political struggles, LVC is now significantly dedicated to building peasant schools and territorial processes to scale up agroecology practiced by small scale producers of food, as part of advancing from 'discourse' to real transformation of material reality.

The New Malthusianism: a Symposium Last workshop of MAVA's «A Sustainable Human Niche?» project

Recent studies project populations reaching levels of 12-14 billion individuals by the end of the century. This raises a set of questions regarding food security, pandemic threats, and environmental crises. These issues relate back to Thomas Malthus and the concerns he raised relating to resource scarcity and human population levels, and their interaction.

On the occasion of the 220th anniversary of Malthus' Essay on Population, a symposium was convened at his Cambridge College — Jesus College — to consider more recent explorations of Malthus and Malthusianism. Economic historians, population/land use modellers, growth theorists, and resource economists presented new or current insights to be derived from more recent studies related to Malthusianism.

Professor Partha Dasgupta presented a stimulating keynote to kick off the symposium. The twenty participants presented a raft of stimulating papers arising from Malthusian thought and motivated by current studies, new projections and historical data. The papers ranged from new theories of unified economic growth via sophisticated democratic projection models to new and striking evidence on the evolution of real wages in England over the past 300 years.

The New Malthusianism Symposium was sponsored by the MAVA Foundation and the Cambridge Institute for New Economic Thinking in celebration of the 220th Anniversary of the publication of Malthus' Essay on Population and organised by Professor Tim Swanson, Dr Toke Aidt and Ms Andhina Kusumawidjaja.

Dr Joëlle Noailly and the 'Financing Investments in Clean Technologies' project team, composed of Prof. Gaétan de Rassenfosse (EPFL), Laura Nowzohour (PhD Candidate, IHEID) and Matthias van den Heuvel (PhD Candidate, EPFL), went to Bern to present the project's progress at the 2nd programme conference of NRP 73.

The conference was a good platform to strengthen the dialogue between the various actors and provided a sound basis to achieve the programme's objectives to contribute to a more sustainable economy.

The Farming of Trust: Organic Certification in Uttarakhand

In the Doon Valley of the northern Indian state of Uttarakhand, the state government has supported certified organic agriculture since the early 2000s. Although practices of record keeping and inspections required by organic certification were intended to make agrarian practices legible and transparent, in practice they often failed to do so. Shaila Seshia Galvin, explored this issue in an article published last November in the American Ethnologist.

Yixian Sun, Postdoctoral Fellow, Yale University

In December 2018, I became a postdoctoral fellow at Yale University, thanks to the financial support of the Swiss National Science Foundation. At Yale, I joined the School of Forestry & Environmental Studies to work at the Governance, Environment, and Markets (GEM) Initiative, and am also affiliated with the Yale MacMillan Center for International and Area Studies.
