As health moves beyond the purely technical to become an ever more critical element in foreign policy, security policy and trade agreements, new skills are needed to negotiate global regimes, international agreements and treaties, and to maintain relations with a wide range of diverse stakeholders in this area.

The Certificate of Advanced Studies in Global Health Diplomacy provides the opportunity to learn about current global health issues from renowned experts and diplomats, to reflect upon the interface of global politics and domestic policies, and to navigate complex governance systems to attain better health outcomes.

OBJECTIVES

- Understand the system and method of global health diplomacy and the importance of governance for health
- Develop knowledge on the political determinants of health and engage in related cross-cutting themes
- Learn about instruments, actors and venues of global health diplomacy in a changing international context
- Enhance negotiation skills and practice strategic thinking in policy making on global health

All our modules are highly participatory, drawing on the national and international professional experiences of participants through a multi-disciplinary learning process. They include lectures by internationally-renowned experts and negotiators, case studies, and working groups. Skill-building activities will complement the learning experience.

AUDIENCE

The target audience includes decisions makers and representatives from governments, international organisations, global health initiatives and other stakeholders in global health, such as civil society, foundations, private sector, networks and alliances.

DEGREE

Successful participants will receive an Executive Certificate (Certificate of Advanced Studies) in Global Health Diplomacy from the Graduate Institute of International and Development Studies (15 ECTS). PROGRAMME CONTENT

MODULE 1 - Global Health Diplomacy

This module is mandatory to all participants. It provides insights into today's landscape of global health diplomacy, organisations and stakeholders involved, venues, instruments and processes. It encompasses the analysis of the dynamics of recent negotiations and highlights current thematic priorities in global health. This module extends over a period of 5 days and can be attended either in English or in French.

MODULE 2 – Two Thematic Tracks

Participants are offered the choice to further build their knowledge in the field of global health and choose between one of the following two tracks:

Track 1: Global Health Instruments and Participatory Processes

This track provides more in-depth knowledge on both the instruments in global health and the characteristics of multi-stakeholder processes. It is composed of a 3-day course on *Negotiation of Global Health Instruments* and a 3-day course on *Global Health Diplomacy by Cities*.

Track 2: Negotiating Intellectual Property and Trade for Global Health

This track provides a basic understanding of intellectual property and trade concepts and explores their relationship to global health. It promotes an understanding on how health concerns can be better integrated into trade and IP-related agreements.

MODULE 3 – Elective Topics of Specialization

Participants have the opportunity to explore other issues linked to global health diplomacy, through the choice of two specialised courses among those on offer each year. The list of available specialised courses is regularly updated to follow ongoing global health debates. Please check the website for an up-to-date list of elective topics. In addition to the tracks above, those can include:

- Global Health Diplomacy by Cities
- Global Health Diplomacy and Drug Policies
- Health Diplomacy and the Humanitarian Space
