**Of the Contemporary Global Order,  
Crisis, and Change**



The contemporary global order is widely said to be in crisis, but wherein does this “crisis” consist? Mette Eilstrup-Sangiovanni and **Stephanie Hofmann** consider the extent to which its basic principles – sovereign inter-state relations and a relatively open global economy – are currently endangered, and conclude that what we are witnessing is not the collapse

of the current world order, but rather its transformation and adaptation into a broader, more flexible and multifaceted system of global governance (in *Journal of European Public Policy*, online October 2019). [DOI >](#)

### **The Institutional “Hinge”: How the End of the Cold War Conditioned Canadian, Russian, and Swiss IR Scholarship**

This article (in *International Studies Perspectives*, ekz021, October 2019) focuses on the linkage between key global moments and the institutional factors that condition IR scholarship. Using the case studies of three central parties to the Cold War conflict (Russia as representative of the Eastern bloc, Canada of the Western alliance, and Switzerland as a neutral polity), **Thomas Biersteker** et al. show how funding schemes, the marketisation of education, and the creation of new IR departments operate as effective “hinges” exerting significant influence over the ways scholars develop ideas about international relations. ### **The Role of Youth in Achieving the SDGs: Supporting Youth-Led Solutions for Sustainable Food Systems**

Increases in agricultural productivity and broader rural transformation critically require skills and knowledge that rural youth are more likely to possess over older adults. Accordingly, **Dario Piselli**, researcher at the Centre for International Environmental Studies, et al. examine the negative impacts (outmigration, unemployment and poverty) of unsustainable food systems on rural youth, before focussing on young people’s actual contributions to sustainable food system transformations, as well as on the importance of addressing the barriers that face them (in *Achieving the Sustainable Development Goals through Sustainable Food Systems*, R. ### **A Wig for Arbitrators: What Does It Add?**

This essay by **Thomas Schultz** and Clément Bachman first reviews the arguments advanced in favour of hybrid international commercial courts – the return of the state and the judge in the world of private international dispute resolution, with expectations of better societal representation and the ameliorating invisible hand of competition on the dispute resolution market; it finds no serious support for them and argues that the development of hybrid commercial courts may backfire, further

environmental protection. In contrast, industrial farmers carry out seed saving surreptitiously to minimise production costs and to resist the enclosure of seeds by corporations. However, both types of seed saving practices challenge corporate seed control. Can they be considered forms of seed sovereignty activism? ask **Diedo Silva Garzón**, Post-Doctoral Researcher at the Democracy Centre, and Laura Gutiérrez in their contribution to *The Journal of Peasant Studies* (online November 2019). 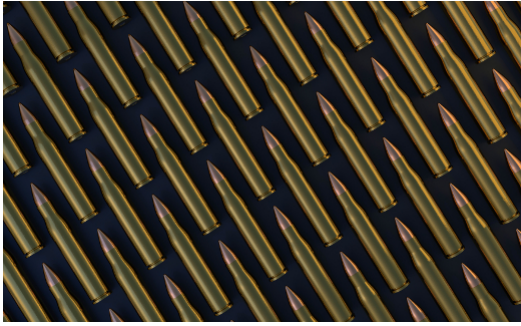
### **Women in Peace and Transition Processes: Somalia (2002–2004)**

Women had an intermediate influence over the Somalia National Reconciliation Conference held in the Kenyan cities of Eldoret and Mbagathi between October 2002 and October 2004. **Jasper Linke**, PhD candidate in Development Studies at the time of reporting, shows that their crucial role as brokers between the conflict parties prevented the negotiations from collapsing. The exercise of power permeates global governance processes, making power a critical concept for understanding, explaining, and influencing the intersection of global governance and health. This article by **Suerie Moon** presents and discusses three well-established conceptualisations of power – Dahl's, Bourdieu's,

While international biodiversity law was not designed with health in mind, it may have significant consequences for sharing human pathogens for public health purposes. This chapter, co-authored by **Gian Luca Burci**, analyses the relationships between the biodiversity regime and the WHO framework to share influenza viruses from the perspective of mutual supportiveness between overlapping regimes rather than the establishment of a hierarchical relationship (in *Environmental Health in International and EU Law: Current Challenges and Legal Responses*, St. Negri, ed., Routledge, November 2019). **The Hazards of Mainstreaming: Climate Change Adaptation Politics in Three Dimensions**

**Follow the Leader? Testing for the Internalization of Law**

Shaun Larcom, Luca Panzone and **Timothy Swanson** empirically test how law is internalised by attempting to disentangle the impacts of a legal change (a 5-pence charge on the use of plastic bags) on intrinsic motivation and individual choice. They measure behaviors and attitudes before and after the legal change and compare the

impacts across neighboring jurisdictions without the change. They find evidence for the internalisation of the law. However, using mediation analysis, they also find that internalisation of the law explains only around 5–8% of the change in behavior, the rest being attributable to the direct effect of the charge (in *The Journal of Legal Studies*, vol. 48, no. 1, January 2019). ### **The Impact of Compliance Committees under Multilateral Environmental Agreements on National Legal Orders**

This PhD thesis in International Law (2019) assesses the impact that 18 compliance institutions operating under multilateral environmental treaties have had on national legal orders. The impact varies greatly, ranging from very low (almost none) to high (almost 85%). In their critical examination of the WDR 2017, **Shalini Randeria** and **Lys Kulamadayil**, Research Associate at the Global Governance Centre, find that it marks a shift away from the single-minded worship of the market and from the elevation of the state and the rule of law to the World Bank's pantheon (in *International Development Policy*, online December 2019). Its expansive polytheism now includes law and recognises its local plurality along with its imbrication in power asymmetries. ##### **Euro Area Sovereign Debt: Restructuring Options**

Should countries with large debts stocks put in place mechanisms that will help them better prepare for the possibility of crisis? In effect, the choice is whether to buy insurance, with the risk that that markets see such proactive steps to protect against a crisis not as an indication of prudent governance but rather as an indicator that a crisis is imminent. In this International Economics Department Working Paper (no. 18/2019, November 2019), Theresa Arnold, Mitu Gulati and **Ugo Panizza** use the case of Italy to set forth its options, as of 2019, to anticipate a possible future debt restructuring. It can: do nothing, do a little; and do something substantial.

##### **A "Protest of Humanity": Human Dignity in International Law**

In about a century and a half, human dignity has moved from the fringes of the international legal system to its centre.

**Ginevra Le Moli** offers in her PhD thesis a theoretical, historical and juridical exegesis of the system from the perspective of

human dignity. She concludes that human dignity, first in its religious and then in its secularised conception, was turned into a platform against sovereign dignity that would in time conquer, through a range of legal instruments, vast sways of international law where sovereign dignity had previously ruled unchallenged.

Newly democratic states virtually always repay the debts incurred by previous non-democratic regimes even though it seems morally problematic to hold them responsible for debts raised without the input of the population. In her PhD thesis in International Law (2019), **Kushini Sugathapala** shows how states in transition

could use transitional justice tools to find alternatives to continued debt repayment.

### **"The Hidden Hand of the Market Will Never Work without a Hidden Fist": History-Making between Capital and Empire**

This paper by **Benjamin Gaillard**, Master Candidate in International History, calls for an anchoring of histories of empire within broader histories of political economy;

argues for a networks-based approach of state as well as non-state actors straddling political, economic, and cultural spheres; advocates for a historiographical shift from the notion of "empire" to that of "the imperial"; and encourages historians writing on empire to resort to multidisciplinary approaches.
