Programme content

The course will:

- Introduce and analyse the overall structure, types and characteristics of the current international health instruments and mechanisms used in global health governance
- Explain the dynamics, lessons learned and negotiation process for both hard and soft law, using examples of the FCTC, IHR 2005, int'l standards as well as selected codes, strategies and frameworks
- Explore other health-related international legal regimes such as those on drug control, environmental protection, human rights and international trade
- Experience and learn negotiation skills through negotiation simulation exercise on a global health instrument
- Discuss global health instruments of the future
